DECEMBER BOARD MEETING NOTES

SECRETARY'S NOTES FROM THE BOARD MEETING, DECEMBER 14, 2004

Facility Electrical Evaluation

Carr Electric was contracted to survey our existing electrical capabilities and to recommend a solution to meet the future needs of the club.

ADA Compliance Project

Harbor & Facilities is to contact Claussen Engineering and ask why we have not received anything meaningful from them. They need to give us detailed drawings of their proposal with their report describing the project. Jim Hachman is to sit with the incoming Port Captain Tom Lueck and update him on the project and ask him how to move forward with the project.

Insurance Non-Compliance

A new letter was reviewed and approved by the Commodore, Vice Commodore and Treasurer. It is now ready to be sent out to non-compliant tenants and will be signed on behalf of the Board of Directors.

Ad-hoc House Committee

The Commodore and Debbie Walker did their research on the description of responsibilities of the last House Committee.

Roster

Debbie Walker submitted a CD to the incoming Commodore containing all the updated Bylaws and members and is ready for printing.

Adult Learn to Sail

Nancy Farnum submitted to the board the 2005 Adult LTS Schedule.

FBLI - Al Farnum

FBLI has met twice to receive the initial budget projections from the various committees as mandated in the Bylaws and to review Insurance proposals from 3 different insurance brokers desiring to meet our needs for the coming year. All of the committees, save the Learn to Sail committee have submitted budgets.

Acordia Brokers of Sacramento has been our primary supplier for our liability insurance for the past several years and has been essentially unchallenged as they did not submit their final bid until too late to shop for any other carrier. This past year, FBLI initiated a new policy in which we invited a number of brokers to bid on our business including Acordia. We had three responses to our call for bid. Acordia, Bay Risk and Bertilacchi Insurance.

FBLI prepared a comparison and based on a personal presentation by Bay Risk, FBLI is recommending that we switch our liability policy to Bay Risk for the year beginning 1-1-05. There will be some minor modifications that should result in an even lower premium by initiating this new competitive bid policy.

Harbor and Facilities - Doug Haas

The building at the point was discussed at the Harbor & Facilities Meeting. The restrooms and showers will be gutted and set-up for storage, one for regatta storage and one for sailing education storage.

Edgar will replace some worn and weathered wiring on the small crane. The crane inspection company recommended the work.

Majority of the meeting was spent discussing the five-year plan.

A subcommittee will also review the events that qualify for bonehead status for 2004 and appoint an appropriate presenter and recipient.

By-Law Amendments:

To amend Article III #6 as follows: PASSED

The Board of Directors may determine the amount of initiation fee, if any, and monthly dues payable to the corporation by members of each of the various membership categories. Changes to initiation fees, membership dues and any other fees shall be read at two board meetings prior to a vote and shall require a two-thirds vote of the Board of Directors present. After the first reading before the Board of Directors the proposed changes shall be published in the club newsletter. If approved by the board of directors, the proposed fee changes shall be adopted. A schedule of revised fees shall be published in the minutes and posted in the clubhouse.

To amend Article VIII #1 (B) as follows: PASSED

(B) Junior Memberships shall be available for any person who is not a dependent of a Family Member and wants to participate in the Stockton Sailing Club Junior program or is a dependent of a Family Member and is between the ages of eight and twenty one (twenty four if currently in school). A junior member shall have all the rights and privileges granted by the by-laws and policies of the Stockton Sailing Club, with the exception of holding office, voting or incurring indebtedness.

The membership is terminated on the twenty first birthday or at the age of twenty four if a full time student. All dues paid while holding this membership category are applicable to any required family membership initiation fee if, within six months of reaching maximum age, application is submitted for a family membership and approved.

THE TRIP SOUTH

Again, with the blue skies and 4-foot following sea, the NW breeze built to a howling 17 knots for most of the afternoon -just enough for *Aztec* to shred a light-air reacher, but not enough to even raise "concern" among the other participants.

We arrived in SC after the harbormaster had gone home so were instructed by the nite person to tie up at the fuel dock, which we did. In order from the Sea proceeding inland we were *Aztec*, *SirLeansalot* and *Hoistafew*. *Aztec* had a very bouncy ride at the dock all nite long as did *SirLeansalot* and to a lesser extent *Hoistafew*. Both the other boats flattened fenders and snapped docklines, and nobody slept well. But, you know, it got pretty bouncy off Pt. Reyes too. (Yea, I

know you other north guys – there's no comparison!) And anyway, there's a great restaurant right up the hill from Santa Cruz harbor where we had yet another in an unending series of fantastic meals.

So then, the next morning just me and my Sweetie left Santa Cruz for Monterey as both *Aztec* and *SirLeansalot* had other plans/obligations. So from here on I can lie like a big dog and nobody will know hahahahaha. Aarrrrhhhh. The waves were like mountains and the wind blew a steady hunderd and ten – arrhhh! Anyway ,we arrived in Monterey way earlier than we'd planned so we went for a bite to eat. We had just settled down with a view of the harbor and glasses of wine when the *Worldwind* came spinning smartly by turning and making her way to her slip. Looked very salty. I can't say too many nice things about Jim because he gets suspicious, but anyway, the boat was looking good. The next day Saundra's folks came for a visit. They live in a retirement home in Carmel Valley and are both past the mid-eighties. We met them and had a nice meal (natch) and then went for a short cruise around the harbor. They were stoked and we were very happy to share this experience with them, something a little different.

The next day was Thursday I think and a beautiful day it was. On the way south SirLeansalot had seen some whales and we

We kept on going that way and all of a sudden found we were in a pod of five whales and so close we could smell their breath. It would take a couple of truckloads of Listerine to get one of these in shape for a whale date. Sweetie felt very peaceful and serene there with them; a sort of aura, she says. I just couldn't get past the bad breath. But all seriousness aside, it was a pretty neat experience. Also, a very odd thing was that there was a group of about 20 seals, all in a very tight group, hanging around with the whales. Some kind of symbiotic relationship I suppose.

Well, we cruised along with these whales for about a half hour and finally decided it was time to head back towards Half Moon Bay. Just about this time there was a change in the weather. The fog came, and it got cold and the wind picked up from the North so that we were soon making only about 3.5 knots. A few calculations and it became apparent we wouldn't get to port in time for supper. Dang. I hate missing a meal and on this trip and I had certainly forgotten what it felt like! I knew we should have put a harpoon in one of those whales going north. Anyway, we plowed on thru the fog and against the wind and with visibility down to maybe 50 feet at times, then it got dark. I was trying to remain unperturbed so as not to upset my Sweetie but I was sweating it a little bit. Turns out the compass light didn't work so I was using a flashlight to see the compass but then I just started steering by the GPS. What a great invention. Finally at 10 PM we felt our way into Half Moon Bay harbor. After that day, we felt ready for the Horn. Almost. OK, not even close, but definitely a little salty. It was really a good feeling to tie up and have that day over, even if I did miss supper

Next morning, a great breakfast, natch, and an uneventful sail on to the cozy dock in Richmond and one, last, final fantastic meal at the restaurant near the harbor. MMMmmm, life is good. A great week! Actually a great couple of weeks to Tomales Bay and Monterey Bay!
