The yacht club type of flag pole is not really considered to be a pole. It represents a sailing ship's aft mast, with a lower mast, a gaff, and a yardarm. The topmast is connected at the doubles. According to protocol, the American flag is flown from the gaff, and the ship's pennant (in our case, the club burgee) is flown from the topmast. In memorial, the burgee is lowered to half topmast.

The CLUB MEMBERS ONLY plaques on the front posts were cast from scrap brass at Rick Pahl's dad's foundry. Bob Winter made the pattern. It is interesting to note that the textured background of the plaques was made by the impression from the back side of a Masonite board.

From the Office

In order to get more value from our Learn to Sail grant funds the Board is considering a new position that would give the Program hands-on leadership. Some of the responsibilities will include equipment purchases and maintenance as well as advertising, program staffing and training issues. More details on this later.

As we move closer to dredging, there is discussion about which maintenance issues, equipment replacement and club projects need to be addressed next. This is discussion for the Harbor & Facilities committee, so please attend those meetings if you have any input. The topics from all committee meetings will help to shape the budget for next year and years to come. The Harbor and Facilities Committee meets at 7:00 p.m. on the first Thursday of every month.

During October there will be a new system installed in the clubhouse, replacing the existing system where food and beverage purchases are made. This has been an ongoing project since approval in May has been in the programming stages since that time. I will receive training as soon as I return from vacation and installation should be completed by mid-October. Member training information will be announced using the Phone Tree.
