### 2020 Single-Handed Race

#### Notice of Race

Event Date: July 25, 2020

#### 1 Rules

- 1.1 This event will be sailed in compliance with the most recent [San Joaquin County Covid-19 Health Order](#), and as it is amended or extended.
- 1.2 The sailing part of this race will be governed by the Rules as defined in the Racing Rules of Sailing (RRS), this NOR, and the SSC Standing Race Instructions.

#### 2 Eligibility

- 2.1 Open to Stockton Sailing Club members in compliance with the latest [San Joaquin County Covid-19 Health Order](#).
- 2.2 All yachts must meet NCPHRF minimum requirements, and have a NCPHRF, or Stockton Sailing Club PHRF rating.
- 2.3 In the event that identical boats rate differently under the two PHRF rating systems, Stockton Sailing Club ratings will apply.

#### 3 Entries

- 3.1 The entry fee is \$0.
- 3.2 Enter by reporting to the starting prior to the starting signal. You can declare your sails to be used by texting your entry to 209-981-5598 before the warning signal - include skipper, boat name, sail#, sails to be used (genoa/110 jib, spin/nospin).

#### 4 Schedule

- 4.1 The date of this event is: 07/25/2020
- 4.2 Scheduled times for this event:

1200 Scheduled start

#### 5 Racing Area

- 5.1 The racing area will be on the San Joaquin River adjacent to the Stockton Sailing Club.

#### 6 Course

- 6.1 The course will be: Start, 29-Port, E-Port, Finish.

#### 7 Scoring

- 7.1 The race will be scored PHRF Time-on-Time.

#### 8 Assignment to Division

- 8.1 Division assignments will be based upon the number and types of entrants.

### **9 DOCKAGE**

- 9.1 Boats leaving and returning to A-Dock and the hoist area shall always maintain at least six feet social distancing. No side-ties/rafting allowed.

### **10 COMMUNICATIONS**

- 10.1 The Race Committee will use VHF radio channel 72 to communicate information about time to start, commercial traffic advisories, and other safety announcements.

### **11 PRE/POST RACE**

There are no pre or post-race meetings or events associated with this race. After returning to the dock, all competitors shall follow all notifications posted at the Club, or communicated via any means to club the membership, related to Covid-19 procedures concerning social distancing, personal protection equipment, and restricted access to facilities.

Competitors participate in the regatta entirely at their own risk. See rule RRS 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
